These holes may be limited at any time by the golf course. Jägare Ridge maintains discretion regarding whether you are permitted to have any types of these holes on the golf course. There is a minimum \$100 charge to cover servers for the liquor holes on the golf course.

Hole Sponsor and Set-Up

We allow outside Hole Sponsors who do not serve alcohol on the golf course, but these sponsors must be fully self-sufficient. Jägare Ridge does not supply tables and chairs for these sponsors. It is the responsibility of the Tournament Organizer or the company involved in the Hole Sponsor. Jägare Ridge maintains discretion regarding whether you are permitted to have some or any of these types of holes on the golf course. Jägare Ridge golf club will help in transporting the Hole Sponsors to and from the holes that have been allocated to them by the golf course and the Tournament Committee.

<u>Jägare Ridge Golf Club - Tournament Agreement</u> Terms and Conditions

This	agreement ("Agreement") made this day of, 2018, is between Jägare
Ridg	ge Golf Club, operated by Whitemud Creek Ranching & Development Corporation, ("Jägare
Ridg	ge"), and (the "Renter"), collectively referred to as the
"Par	rties."
In c	onsideration of the mutual promises and covenants contained herein, the Parties agree as

	his Agreement the term "Golfing" includes use of all Jägare Ridge's facilities, including
	nout limitation: fairways, greens, driving range, restaurant, parking lots (the "Facilities") and
rent	al and use of golf equipment including power carts (the "Equipment").

1.	Final Numbers. The Renter will provide the Estimated Number of Golfers for the
	tournament at least 10 days prior to the event. Further, the Final Number will be provided
	no later than 72 hours (3 days) before the event, which shall not be less than 90% of the
	Estimated Number (e.g. If the Estimated Number is 100 participants, the Final Number cannot be less than 90 participants). The Renter will be charged for the Final Number or
	actual number, whichever is greater.

2.	Weather. All golf tournaments are rain or shine events, and will be held under these
	conditions unless severe weather (i.e. lightning) occurs in which case our Rain Check Policy
	comes into effect.
3.	Venue Rental. Jägare Ridge hereby permits the Renter to use the clubhouse venue
	("Venue") and the golf course on the Event Date, during the hours specified below, and
	only for the purposes set forth in this Agreement.
4.	Event Date. The Event shall be held on the date listed below. The Event Date shall include
	the following activities: set-up, function/dinner, and tear-down. The Renter shall not have
	access to the Venue at any time other than during the Event Date, unless the Renter receives
	prior permission from the Food and Beverage Manager, Tyler Rumpel (the "Manager").

5.	Fees. The Renter shall pay to Jägare Ridge total fees including a Rental Deposit of \$500 for
٥.	the use of the Venue as listed below. The Rental Deposit will be applied to your final bill,
	and must be paid to Jägare Ridge upon execution of this Agreement. Following the Event,

the Manager will provide the Renter with a final invoice to reconcile the account. **Payment** is due in full 20 days after the Event Coordinator receives the final invoice. Any

outstanding balances beyond 20 days after the final invoice is received will be charged to the credit card on file.

- 6. Cancellation. If the Renter cancels the reservation for the Event within thirty (30) days or more of the Event Date, the Manager shall refund to the Renter the Rental Deposit; if the Renter cancels the reservation for the Event within thirty (30) days or less of the Event Date, the Rental Deposit may be retained as liquidated damages under Jägare Ridge's discretion. Further, if the Renter cancels the reservation for the Event within fourteen (14) days or less of the Event Date, the Food and Beverage Fee based on Estimated Numbers may be retained as liquidated damages.
- 7. Use of Facilities and Equipment. The Renter shall leave the Facilities and Equipment in the same or similar condition as when the Renter arrived and found them. Rental of the Equipment from Jägare Ridge is for the number of holes of play on the Event Date. The Equipment is not to be removed from Jägare Ridge's golf course property, and is to be promptly returned to Jägare Ridge after use. The Renter represents that they are familiar with the operation and use of the Equipment and acknowledges receiving the Equipment in good order and repair. The Renter agrees to keep the Equipment in their custody, and acknowledges that they are liable to pay Jägare Ridge costs to repair all damages to the Facilities and/or Equipment beyond ordinary wear and tear.

NOT MORE THAN TWO PERSONS AND TWO GOLF BAGS SHALL BE IN A GOLF CART AT ANY ONE TIME. NO PERSON SHALL DRIVE A GOLF CART WITHOUT POSSESSING A VALID DRIVER'S LICENCE AND BEING EIGHTEEN YEARS OF AGE OR OLDER.

- 8. **Permitted Use/Transportation.** The Event shall not be open to the general public, and may only include invited guests. Patrons are encouraged to make driving arrangements in advance to ensure they have a safe ride home. Uber and taxi services are readily available.
- 9. Supervision of Minors/Restrictions. The Renter is responsible for providing supervision of minors under the age of 18 while at the Venue. Minors are not permitted to drive the golf carts. Stapling or nailing of decorations is not permitted; however, scotch tape may be used.
- 10. Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement. THIS WILL AFFECT YOUR LEGAL RIGHTS: PLEASE READ CAREFULLY.

The Renter acknowledges and agrees that the Renter assumes all risk of personal injury, death or property damage, to themselves or others (including minors accompanying them), resulting from any cause whatsoever, including without limitation: all of the risks inherent in the playing of golf (the topography of the premises, proximity of any housing, water features etc.), the rental of the Equipment, the use of the Facilities and the Equipment, collision with other objects, negligence, breach of contract, breach of statutory duty of care

on the part of Jägare Ridge Golf Club, the corporate owners inclusive of Jägare Ridge Communities Inc., Whitemud Creek Ranching & Development Corporation, Qualicare Health Services Corporation, Melcor Developments Inc., and including all of the aforementioned companies' employees, agents, directors, shareholders, representatives, successors and assigns (collectively referred to as the "Releasees").

The Renter specifically acknowledges and agrees that the Releasees shall not be liable for any such personal injury, death or property damage and releases the Releasees and waives all claims with respect thereto. The Renter agrees to indemnify and hold the Releasees harmless from all such damages which might arise directly or indirectly from Golfing at Jägare Ridge.

The Renter shall immediately notify the Manager of any damage or injury of which they have knowledge in, to, or near the Facilities, regardless of the cause of such damage or injury.

I HAVE READ, UNDERSTOOD AND ACCEPT THE CONDITIONS OF THIS RELEASE AGREEMENT AND WAIVE MY RIGHT TO SUE.

- **11. Severability.** If any part of this Agreement shall be held unenforceable for any reason, the remainder of this Agreement shall continue in full force and effect.
- **12. Entire Agreement.** This Agreement constitutes the entire agreement between the Renter and Jägare Ridge, and supersedes any prior understanding or representation of any kind preceding the date of this Agreement.
