## **Application Agreement**

### **General Information and Terms of Membership**

- Our philosophy at Jagare Ridge is to create an opportunity where the rewards and traditions of golf can be enjoyed in a relaxed environment and magnificent natural setting. We endeavor to provide a high level of service to you, both in terms of personal service and course quality. We realize how important your leisure time is to you. If at any time you do not feel that you have been treated in a respectful manner or have not enjoyed your experience here, please inform us immediately.
- Jagare Ridge is an environmentally sensitive course and a proud member of the Audubon Cooperative Sanctuary Program. Our focus is on preserving key habitat areas and wildlife corridors. We practice environmentally responsible maintenance programs and ongoing habitat enhancement. We ask that you respect this natural environment.
- **All fees are due in full by March 31, 2020.**
- **Memberships are limited, and are valid for the upcoming season only, no exceptions.**
- All members and guests must check in with the Pro Shop prior to playing our course.
- When booking tee times, a player must identify him or herself as either an unrestricted member, restricted member or corporate member designates and have his or her membership number or corporate ID ready.
- Corporate passes and memberships are not valid for tournament play.
- Once Corporate passes are issued, they are not replaceable if lost or stolen.
- Each tee time is extremely valuable to our facility. Failure to provide 24 hours' notice to cancel a tee time will result in a fee being charged.
- Adherence to a respectable and reasonable dress code is appreciated.
- Jagare Ridge is a soft spike facility.
- The season ends at the discretion of Jagare Ridge management, usually in mid-October.
- A Code of Conduct is in place to ensure appropriate treatment of all members, guests and staff. Inappropriate conduct may result in the individual being asked to leave in addition to forfeit of membership. Further, Jagare Ridge reserves the right, in its sole and unrestricted discretion, to refund unused membership fees paid and withdraw membership from any member where irreconcilable differences arise.
- Additional fees will be charged for league and member events (i.e. meals and prizes).
- Jagare Ridge management reserves the right to suspend play or the use of power carts due to inclement weather and difficult course conditions to ensure the safety of our golfers, and maintain the integrity of our course.

- To ensure the pristine condition of our course and a pleasant experience, we ask that you repair any divots with sand, rake the bunkers, repair ball marks, and maintain a reasonable pace of play.
- Use of course facilities is subject to occasional maintenance closure.
- **Restricted Members: Membership valid for play Monday through Friday, not including holidays; may play on weekends and holidays by paying the discounted guest rate.**
- **Intermediate and juniors may play 7 days per week, and on weekends and holidays after 1:00 pm.**
- Corporate Designates from each corporate package shall have access to course facilities and primary golfing privileges. Corporate Designates are required to use a corporate pass for golfing privileges.
- Utilization of the short game practice area and the west end of the range is available to members (including appointed corporate members only) and only when it is not being used as a spare hole. Corporate members may choose individuals from their company who will have access to the short game facility as well as the west end of the range for the season. Access and use of this area will be monitored and restricted to ensure everyone's safety. Power carts are permitted to be taken to the short game area only on a limited basis due to limited space at the facility and required availability for golfing clientele.
- Jagare Ridge Golf Club is an AGLC licensed facility, and pursuant to the regulations outside alcohol is not permitted on our course or premises. Failure to adhere to this policy will result in the confiscation of alcohol and may result in being asked to leave the premises.
- Cannabis use is not permitted at our facility.

## Power Cart / Club Storage

- Please check your power cart for damage prior to use, and report any malfunction issues experiences and/or any misuse witnessed to the Pro Shop immediately.
- Damage incurred to your power cart while in your possession is your responsibility; any damage will be billed to you at our cost.
- Cart operators must be at least eighteen (18) years of age and must hold a valid driver's license.
- No more than two (2) people shall occupy a power cart at any given time.
- All members are required to have proper insurance if storing golf clubs at our course which may be obtained through a home owner's endorsement. While we endeavor to maintain reasonable measures to secure personal property and guard against theft, **Jagare Ridge is not responsible for clubs or equipment that is stolen or damaged while left or stored at our facility.** Storage is included on a gratuitous basis with all memberships and we cannot guarantee or warrant against incidents of theft.

## Waiver of Liability

This is a challenging golf course with many elevation changes and hazards. The Applicant(s) shall be conclusively deemed by his or her signature on this Form to have agreed that neither Whitemud Creek Ranching & Development Corporation operating as Jagare Ridge Golf Club, nor Jagare Ridge Communities Inc., nor any of its directors, officers, shareholders, employees, corporate affiliates, or agents of each respective corporation (the "Releasees") shall be responsible in any way whatsoever for any loss or damage to the property of the member (including golf clubs, bags or contents thereof) or any personal injury (including injury resulting in death) to the membership holder or membership holder's guest while on or about Jagare Ridge's premises or any of its facilities, and including while participating in any activities thereof; this also includes any injuries which occur while using the Club's golf carts or any injuries or damages occurring while utilizing Jagare Ridge's parking lot and nearby areas. **Further, by signing this Form you agree to release and hold harmless the Releasees from any liability, actions, or claims for damages, whether personal or to property due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care, including any duty of care owed under the Occupier's Liability Act on the part of the Releasees.**
